# The below-named complaining witness being first duly sworn states the following:

### Count 1: REPEATED SEXUAL ASSAULT OF A CHILD

The above-named defendant on or between April 1, 2022, and April 26, 2024, in the City of Fitchburg, Dane County, Wisconsin, did commit repeated sexual assaults involving the same child, Child Victim 1, DOB June of 2015, where at least three of the assaults were violations of sec. 948.02(1)(am), (b) or (c) Wis. Stats., contrary to sec. 948.025(1)(b), 939.50(3)(b) Wis. Stats., a Class B Felony, and upon conviction may be sentenced to a term of imprisonment not to exceed sixty (60) years.

And furthermore, invoking the provisions of Wisconsin Statutes 939.616(1r) and (3), the defendant being 18 years of age or older at the time of the offense, the court shall impose a bifurcated sentence under s. 973.01. The term of the confinement in prison portion of the bifurcated sentence shall be at least 25 years. Otherwise the penalties for the crime apply, subject to any applicable penalty enhancement.

### **FACTS:**

Your complainant is a Court Officer with the City of Fitchburg Police Department and for this complaint is relying on the written police report(s) submitted by City of Fitchburg Police Officer(s) Davan Hamberg and Detective Hector Aguirre.

#### **Initial Information**

On April 28, 2024, an individual walked into the City of Fitchburg Police Department to report a sexual assault of a child. They reported there was inappropriate touching of a child at an address in the 2100 block of Apache Dr, in the City of Fitchburg, located in Dane County, within the State of Wisconsin.

### **Contact with DVG**

Officer Hamberg made contact with an individual whose name forms the initials DVG, who was the reporting party and the grandmother of the victim. The victim was identified, but will be referred to as "Child Victim 1" for the purposes of this complaint. Child Victim 1 was born in June of 2015.

DVG stated that Child Victim 1's stepfather, who was verbally identified as **WILLIAMS J. MONGE** (the defendant, hereinafter), is sexually abusing her granddaughter, Child Victim 1. DVG informed Officer Hamberg this sexual abuse has been occurring at the address on Apache Drive in the City of Fitchburg since late 2021. Child Victim 1 told DVG that the defendant has been putting his penis in her vaginal and anal areas for approximately two years. Child Victim 1 reported to DVG that there is a lot of bleeding after the sexual acts occur.

Child Victim 1 specifically stated that when the defendant put his penis in her anus, there was a large amount of pain to the point where she felt like she was dying/going to die. Child Victim 1 stated during the sexual acts, she would bite her mouth from the large amount of pain that she was feeling. Child Victim 1 stated that the defendant threatened to kill her biological mother, an individual whose name forms the initials JYT, and DVG if she told anyone. Child Victim 1 stated that she was very fearful of the defendant and fearful to return back to her own residence. DVG stated that Child Victim 1 advised the last sexual incident occurred sometime this week, possibly April 25, 2024.

DVG was also told that all of the sexual acts occurred at the Apache Drive address inside of the house. The locations consisted of the defendant's bed, JYT's bed, Child Victim 1's bed, the kitchen, and other areas throughout the house.

Officer Hamberg reported it is believed that the defendant is a flight risk due to him having Honduras citizenship.

## **Contact with JYT**

Detective Aguirre made contact with JYT. JYT stated that the defendant's full name is Williams J. Alberto-Monge. JYT stated she met the defendant back in August of 2021 and started dating in September 2021. JYT stated they started living together in January 2022. JYT stated they moved to the duplex where they reside now, in the 2100 block of Apache Dr, in April 2022.

## **Safe Harbor Interview**

Detective Aguirre reported that on May 1, 2024, he observed a Safe Harbor interview of Child Victim 1. The forensic interviewer was Heidi Figueroa-Velez.

Heidi asked Child Victim 1 why she was here, and Child Victim 1 stated, her mom's boyfriend, the defendant, who came from Honduras, touched her. Child Victim 1 stated he put his penis in her private part and one time he put his penis in her behind and it hurt really bad, but he also told her not to say anything or he would kill her mom and her grandma.

Child Victim 1 stated this is why she did not want to say anything because she was really scared, but she was finally able to tell her grandma.

Heidi asked Child Victim 1 to explain the first time that happened. Child Victim 1 stated the first time, the defendant put his penis inside her private part and it hurt. Child Victim 1 also stated she bled this time and removed her underwear because they were bloody and ended up putting them in a plastic bag with lots of papers on top and put the bag in the garbage. Heidi then clarified with Child Victim 1 on what she means by "private part?" Child Victim 1 stated, "Vagina."

Child Victim 1 stated that the first time it happened quickly in the kitchen where he took off only her pants and underwear and he took off his and covered her mouth while he held her arms with one hand and then put his penis inside her vagina and it felt weird and uncomfortable.

Child Victim 1 further explained that he (the defendant) grabbed her hard by her arms to get her closer and told her to be guiet or he would kill her grandmother. The defendant put his penis in her vagina then it stopped when liquid came out of his penis. Child Victim 1 stated the liquid smelled bad and her underwear got wet.

Child Victim 1 stated another time this happened, it was in the defendant's bedroom. Child Victim 1 stated she was taking care of her little brother and the defendant was drunk at that time. Child Victim 1 stated her mom was not there. The defendant did the same thing where she was standing up while in his bedroom and she tried to get away, but the defendant told her that he was going to kill her mom.

Child Victim 1 said the defendant was in the kitchen, but then came into the bedroom and she knew what was going to happen because he has done this to her before. Child Victim 1 stated the defendant took down her pants and underwear and put his penis in her vagina. Child Victim 1 said there were two times that this happened during the day and all the other times it happened at nighttime.

Child Victim 1 also explained that another time, this was at night when her brother, who sleeps on the top bunkbed was asleep and she was sleeping as well. Child Victim 1 said the defendant came into her bedroom and uncovered her and took off her shorts and underwear. Child Victim 1 stated this time it was different as he put his penis in her "back private part" and it hurt a lot.

Child Victim 1 explained she was lying down when this happened. Child Victim 1 said she could not say anything because he said the same thing. He would kill her mom and her grandma. Child Victim 1 stated it hurt so bad that she bit down and bit her lips that she ended up cutting her lips from biting down so hard. Child Victim 1 stated it only happened once to her butt and all the other times, it happened to her front private part.

Heidi clarified and wanted to know what the "back private part" is called, as Child Victim 1 did not know. Heidi asked Child Victim 1 what is that part used for and Child Victim 1 stated, "To poop."

Child Victim 1 stated when the defendant put his penis in her butt, it bled a little and it also hurt. Child Victim 1 described the pain as she felt she was going to die as it hurt very much. Child Victim 1 stated afterwards she went into the bathroom to wipe so she would not bleed anymore.

Child Victim 1 stated they lived somewhere else, but this all started happening when they moved to the duplex that they live at now.

Heidi asked Child Victim 1 if she recalled the last time something like this happened to her, and Child Victim 1 said the last time this happened, she believed it was the day before coming to grandma's house.

Heidi then asked Child Victim 1 to tell her about the pain that she was experiencing, as Child Victim 1 stated that it hurt really bad and thought that she was going to die.

Heidi also clarified that Child Victim 1 said when it happened in the kitchen, a liquid came out of his penis. Child Victim 1 confirmed by shaking her head up and down as if she were saying "yes" or agreeing. Heidi asked Child Victim 1 if when it happened in his bedroom, if liquid came out of his penis, as Child Victim 1 shook her head up and down as if she were saying "yes" or agreeing.

Heidi wanted to know more about when the defendant has unplugged the cameras and if she has seen him do that, as Child Victim 1 stated that she has seen him do this twice, as she stated that there are cameras, one in the kitchen, one in her bedroom, as well as one in his bedroom and saw him move specifically the camera that was located in the kitchen and in his bedroom.
