Complainant, Natalie M Mulvey, an Assistant District Attorney, being first duly sworn on oath, deposes and says that:

Count 1: FIRST DEGREE RECKLESSLY ENDANGERING SAFETY, USE OF A DANGEROUS WEAPON

The above-named defendant on or about Friday, May 24, 2024, in the City of Green Bay, Brown County, Wisconsin, did recklessly endanger the safety of MAH-R, under circumstances which show utter disregard for human life, contrary to sec. 941.30(1), 939.63(1)(b) Wis. Stats., a Class F Felony, and upon conviction may be fined not more than Twenty Five Thousand Dollars (\$25,000), or imprisoned not more than twelve (12) years and six (6) months, or both.

And further, invoking the provisions of sec. 939.63(1)(b) Wis. Stats., because the defendant committed this offense while using a dangerous weapon, the maximum term of imprisonment for the felony may be increased by not more than 5 years.

Count 2: SUBSTANTIAL BATTERY, USE OF A DANGEROUS WEAPON

The above-named defendant on or about Friday, May 24, 2024, in the City of Green Bay, Brown County, Wisconsin, did cause substantial bodily harm to MAH-R, by an act done with intent to cause bodily harm to that person, contrary to sec. 940.19(2), 939.63(1)(c) Wis. Stats., a Class I Felony, and upon conviction may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than three (3) years and six (6) months, or both.

And further, invoking the provisions of sec. 939.63(1)(c) Wis. Stats., because the defendant committed this offense while using a dangerous weapon, the maximum term of imprisonment for the underlying crime may be increased by not more than four (4) years.

Count 3: DISORDERLY CONDUCT, USE OF A DANGEROUS WEAPON

The above-named defendant on or about Friday, May 24, 2024, in the City of Green Bay, Brown County, Wisconsin, while in a public or private place, did engage in abusive, boisterous, indecent, profane, unreasonably loud, violent or otherwise disorderly conduct, under circumstances in which such conduct tended to cause or provoke a disturbance, contrary to sec. 947.01(1), 939.63(1)(a) Wis. Stats., a Class B Misdemeanor, and upon conviction may be fined not more than One Thousand Dollars (\$1,000), or imprisoned not more than ninety (90) days, or both.

And further, invoking the provisions of sec. 939.63(1)(a) Wis. Stats., because the defendant committed this crime while using a dangerous weapon, the maximum term of imprisonment may be increased by not more than 6 months.

Complainant is an Assistant District Attorney with the Brown County District Attorney's Office and knows of the above offense(s) on information and belief based upon:

PROBABLE CAUSE:

The complainant, being duly sworn on oath, swears that she has had the opportunity to review the police reports from officers of the Green Bay Police Department, and other documents supporting this complaint referenced herein, which are the types of reports and documents kept in the ordinary course of business, which complainant believes to be truthful and reliable because they have proven to be truthful and reliable on numerous occasions in the past.

The complainant further asserts that based upon her review of the referenced reports and/or supporting documents, the incidents alleged occurred in the City of Green Bay, Brown County, Wisconsin.

1. Complainant's review of the report of Officer A. Gonzalez-Rodriquez of the Green Bay Police Department, a summary of which indicates the following:

On May 24, 2024 Officer Gonzalez-Rodriquez responded to the area of **** Chicago Street, Green Bay, Brown County, Wisconsin in reference to a weapon call. Officer Gonzalez-Rodriquez was requested to respond to help translate as there were multiple individuals on scene who only spoke Spanish.

Officer Gonzalez-Rodriquez arrived on scene and made contact with two witnesses MAH-A and KOH-A. KOH-A gave a statement to Officer Gonzalez-Rodriquez. KOH-A said that he was in the garage of **** Chicago Street with his uncle REH-A and his cousin MAH-A. KOH-A stepped outside and saw MAH-R and another male Gabino A. Guzman-Lovato (DOB: 03/25/1989) having a verbal argument. KOH-A overheard Gabino say that he was part of a gang and that MAH-R needed to shut up and respect him. KOH-A went to the bathroom for a few minutes and when he came back outside he saw MAH-R and Gabino punching each other. KOH-A then witnessed Gabino pull out a knife from his pocket. Gabino was holding the knife with the blade facing down. Gabino cut MAH-R on the arm, face, and hand. Gabino then attempted to run away and get help by knocking on the said door of another residence.

MAH-A also gave a statement. MAH-A said that he also observed MAH-R and Gabino arguing outside of the residence and heard Gabino say that he was part of gang and that MAH-R needed to shut up and respect him. MAH-A went inside for a couple minutes during the argument and when he came back outside he saw MAH-R had cuts on his hand, arm, and face. MAH-R was trying to get the knife from Gabino and Gabino ended up running away.

2. Complainant's review of the report of Officer A. Jahnke of the Green Bay Police Department, a summary of which indicates the following:

On May 24, 2024 Officer Jahnke responded to the weapon call and made contact with MAH-R. Officer Jahnke observed that MAH-R had large amounts of blood on his shirt and pants, a laceration on his left cheek, a laceration on his upper left arm, and having bleeding coming from his right hand. Officer Jahnke placed bandages on MAH-R's left arm and hand. EMS eventually arrived on scene and transported MAH-R to St. Vincent hospital. Officer Jahnke went to the hospital with MAH-R. MAH-R received medical treatment including stitches placed on the laceration to his left cheek.

MAH-R gave a statement to Officer Jahnke. MAH-R said that he was at his cousin's house on Chicago Street that day where Gabino was temporarily staying. MAH-R said that during the disturbance Gabino had taken out a knife and attacked him. MAH-R said that Gabino said that he was going to kill MAH-R and that Gabino came at him with a knife. MAH-R said he knew he was cut in the face, and upon seeing all his own blood he reached for a rock near his person and struck Gabino.

That was as much information as Officer Jahnke was able to obtain due to MAH-R receiving medical attention and the amount of pain he was in. Officer Jahnke was informed by medical staff that MAH-R's artery in his right hand had been cut and that they were referring the injury to orthopedics to determine if surgery was needed.

3. Complainant's review of the written statement by MAH-R, which indicates the following:

MAH-R was at his uncle's house on Chicago Street and Gabino started arguing with him at around three in the morning. Gabino was telling MAH-R that he was a gang member and trying to threaten him. Gabino has threatened MAH-R in the past and they know each other from living in Salvador. Gabino said this was on behalf of the gang and that he was going to kill MAH-R. Gabino came at MAH-R with a knife and tried to stab MAH-R in the neck. MAH-R was able to dodge the attempt. MAH-R tried grabbing the knife from Gabino and Gabino cut his hand with the knife. MAH-R then fell to the ground and grabbed a rock and Gabino stabbed him in the arm. MAH-R hit Gabino in the head with the rock to try and get Gabino off of him. MAH-R then took off running and Gabino chased him with the knife. MAH-R's cousins were outside and saw what was going on which scared Gabino who ran away while the cousins called police.

4. Complainant's review of the report of Officer N. Bloch of the Green Bay Police Department, a summary of which indicates the following:

On May 24, 2024 Officer Bloch responded to the residence on Chicago Street and observed Officer Rosenau with a male on the east side of the call address. Officer Bloch observed the male to have some lacerations to his chest as well as a red substance that appeared to be

blood on his face. The male was identified as Gabino Adimir Guzman-Lovato (DOB: 03/25/1989). Fire and Rescue arrived on scene and began attending to Gabino. It was determined that Gabino needed to be transported to a local hospital for further treatment.

Officer Bloch rode in the ambulance with Gabino to Aurora Hospital. At the hospital, Officer Bloch was able to obtain a written statement from Gabino utilizing Language Line. Gabino stated that on that day he was working a job near Sturgeon Bay. Gabino finished the job at about 4:30 pm and was dropped off in Green Bay around 6:00 pm. After that, Gabino said that he was with co-workers drinking some beer in a car at a gas station off of Baird Street. After he was done drinking, Gabino said that he was walking back to his house on Chicago Street when he saw three black males with rocks in their hands. Gabino said that he did not know what they were wearing but they hit him on the head with rocks. Gabino said that they then dragged him on the floor in which he then began to run for his life. Gabino said the last thing he remembered was being on the side of the house.

Based on the foregoing, the complainant believes this complaint to be true and correct.
