The below-named complaining witness being first duly sworn states the following:

Count 1: REPEATED SEXUAL ASSAULT OF A CHILD

The above-named defendant between 7/28/2012 and 6/20/2014, in the Village of Cross Plains, Dane County, Wisconsin, did commit repeated sexual assaults involving the same child, JME, DOB 07/28/2007 where at least three of the assaults were violations of sec. 948.02(1) Wis. Stats., contrary to sec. 948.025(1)(d), 939.50(3)(b) Wis. Stats., a Class B Felony, and upon conviction may be sentenced to a term of imprisonment not to exceed sixty (60) years.

FACTS:

Your complainant is a Court Officer with the Village of Cross Plains Police Department and for this complaint is relying on the written police report(s) submitted by Cross Plains Police Officer(s) Scott Kroetz.

Officer Kroetz reports on June 20, 2014, at approximately 4:15 p.m., he received a telephone call from Laura Becher of Dane County Human Services. Becher stated that she was en route to Cross Plains to conduct a field interview of a 6-year-old girl, later identified by her initials as JME (DOB: 07/28/2007), who had been the victim of sexual assault that occurred in the Village of Cross Plains, Dane County, Wisconsin. On June 23, 2014, Jennifer Ginsburg from Safe Harbor interviewed JME.

Ginsburg asked JME if she talked to a lady recently, and she said yes, it was about a friend named Curtis O'Brien, identified as the defendant herein. JME stated that the defendant lives on one side of the house. JME stated that that the defendant "touches me." JME stated, "He touches my butt and my P. Curtis can't be at the house anymore."

Ginsburg asked JME about the touching of her P, and she stated the defendant pushed finger on P, she felt sad. Ginsburg had a drawing of a female body on the board, and Ginsburg asked JME to circle on the lady where her P was. JME circled the groin on the lady. Ginsburg asked JME to circle on the lady where her butt was, and JME circled the butt on the lady. Ginsburg asked JME the defendant's age, and JME said older, but she did not know his age. Ginsburg asked JME what the defendant used to touch her with, and JME circled the fingers on the drawing. Ginsburg asked JME what she used to touch the defendant with, and she circled the fingers on the drawing. Ginsburg asked JME when that happened, and JME said sometimes in the bathroom or basement of her house.

Ginsburg asked JME about the defendant touching her when she was in the bathroom and she stated she was sitting when the defendant touched her P and her butt. JME stated she got an owie on her P which hurt. JME stated that she told her mom and dad about her owie, and it really hurt. JME stated she didn't tell her mom and dad how she got the owie because she was afraid of getting in trouble and that's why she didn't say anything. Ginsburg asked JME if the defendant touched her P under clothes, and she said yes and that her clothes were on. JME stated that the defendant pulled her pants and underwear down. Ginsburg asked JME where the touching happened, and JME said it happened in the bathroom, living room, and basement of her mom and dad's house; Grandma's house and on Grandma's front porch. JME stated the defendant touched her P and butt in her mom and dad's living room, bathroom, and basement. JME stated that the defendant also touched her P and butt on Grandma's front porch while she and the defendant were sitting. Ginsburg asked JME about the touching on Grandma's front porch, and JME stated that the defendant touched her privates and then she went inside. Ginsburg asked JME about the one of the first times the defendant touched her. JME said that she had finished first grade when the touching happened. JME also stated that the touching happened this summer.

Ginsburg asked JME what happened with "C," referring to the defendant. JME stated that the defendant kissed her on the lips a lot of times, he fingered her a lot of times, and put his dick into her "V." Ginsburg confirmed with JME that a "V" is a vagina and then told her that could continue to call it a "V." JME stated that her mother was taking a shower and she soon realized why her "V" hurt for a few days. JME stated the defendant put his dick in her mouth a lot. Ginsburg asked JME how old she was when this happened and she said that she was five (2012) and six (2013). Ginsburg asked JME what made it stop and she said one day she was at grandma's and grandma saw the defendant kissing her on the lips. JME stated Grandma told her mom what happened and her mom walked out of the house later and "I don't want to say what I said. It is so hard. I can not say this or I start bawling." JME stated that her mother heard what she was saying to the defendant on the porch. JME stated she and her mom had a talk when they got home and then her mom told her dad and they called the cops. Ginsburg asked to hear more about the defendant kissing her on the lips. JME stated that the defendant kissed her on the lips a lot in the bathroom and one day he kissed her on the lips downstairs while watching a movie. JME stated the defendant kissed her on the lips one night when her mom walked out of the room.

Ginsburg asked JME about being fingered and where she was. JME stated only in the bathroom and remembered that the defendant kissed her in the car once too. Ginsburg confirmed with JME that it was only in the bathroom and then asked if this was only one day or more than one day. JME stated it was more than one day. JME stated that at first it happened in the upstairs bathroom and the downstairs bathroom, but then recanted and stated that it

only happened in the downstairs bathroom. Ginsburg had JME explain about the downstairs, and she pointed out how everything was laid out in the downstairs. Ginsburg then asked JME about the defendant putting his dick in her "V" and what rooms that happened in. JME stated it happened in the downstairs bathroom a lot. JME also stated that it happened in the upstairs bathroom too. Ginsburg asked JME about the defendant putting his dick in her mouth and she said in the downstairs bathroom only. JME stated when she was abused by the defendant she felt like she just wanted to punch him in the face or call the police. JME stated when the defendant would stick his dick into her mouth she felt like she wanted to bite his "D" and she would go into her wonderful day dreams with ponies and she then felt like she was doing something wrong. JME stated she felt like she was doing something that she shouldn't do and it was scaring her a lot so she didn't talk that much about it when she was little. JME stated that the defendant told her, "Don't tell your mom ever." JME then clarified that the defendant said, don't tell anybody ever. Ginsburg asked JME if the defendant would ever say nice things to her and she said only when people were around. Ginsburg asked JME to tell more about going into the downstairs bathroom. JME stated that the defendant would go in first and then pull her back in. JME stated the defendant would say, get in here. Then he would do the abuse and she didn't want to go through the abuse part again. Ginsburg asked if the defendant would do all these things and she replied, not that much, only some things. JME stated the defendant would mostly kiss her most of the time. Ginsburg asked what the defendant would more, put his dick in her "V" or his dick in her mouth and she said that it was about the same. JME stated that it made her so mad and so scared when the defendant would put his dick in her mouth. Ginsburg asked JME what position she would be in when the defendant put his dick in her mouth and she said that she would mostly be sitting on her knees, and she would sitting on the floor or tub. JME stated that the defendant would put his hand on the back of her head and pull it forward. Ginsburg asked JME what the defendant would do when he put his "D" into her mouth, and she said that it moved sometimes and also stayed still. Ginsburg asked what would happen to the defendant's D, and she said that it would be wet. JME stated because of her drool, she denied anything came out of his dick. JME stated the defendant would just pull it out and put his pants back on.

Ginsburg asked JME about the "V" hurting, and she said because of the defendant putting his dick into her "V." JME stated when she went to the bathroom it would hurt when she went pee and it really hurt. JME told her mom and her mom said that it would be okay and her mom soon realized that it was the defendant. Ginsburg asked JME about the first time the defendant put his dick into her "V." JME couldn't remember the first time but explained a time when it happened. JME stated it happened in the downstairs bathroom and the defendant set her up and pulled down her pants and then he would open her legs and put his dick into her "V." JME stated the defendant would be standing and she would be sitting on the sink. When asked, JME stated that the defendant's hands would be holding her waist. JME stated that it hurt and made her sad a lot. JME stated she was so scared to say anything to the defendant and he did not say anything to her or make noises when he did the abuse. Ginsburg asked JME how it would end and she said that the defendant would just take it out. Ginsburg confirmed with JME that the defendant would say, don't tell anyone when they were in the bathroom. Ginsburg asked JME to tell more about her "V" after that or going to the bathroom and she said that it would be red or would really hurt. Ginsburg asked JME if she would ever notice anything in her underpants and she said no. JME stated that the defendant put his finger in her "V" and her butt. JME stated that the defendant would pull down her pants and demonstrated how he would use his fingers in her "V", and it really hurt. Ginsburg asked JME about the defendant putting his fingers in her butt and she said that the defendant would bend her over and do the

same thing. When asked how it felt, JME stated it really hurt too. JME stated it happened in the downstairs bathroom.

Ginsburg asked JME what made it stop, was it when grandma saw the defendant kissing her? JME said that was when grandma saw the defendant kissing her and what mom heard what she said to the defendant. JME said that she felt so mad at herself and she hated what she said. JME also made the comment about almost killing herself. JME stated she has bad anxiety and she told the defendant he could do anything to her and she is mad at herself and was tiny and did not know what she was doing. JME then confirmed that is what her mom heard. Ginsburg asked how JME felt about the defendant when this was going on and she said that she was going to tell mom, but didn't tell mom because he said he would hurt her. JME stated that the defendant would probably just punch her or steal her so she didn't say anything. JME confirmed that the defendant never said what he would do to her if her mom ever found out but she just felt like he would hurt her. Ginsburg asked JME who the first person she told was, and she said that she told her mother first and her mom told her dad. JME stated she told some other friends. Ginsburg asked JME what the defendant would do with her clothes when he would put her up on the sink and put his dick into her "V." JME stated that the defendant would only pull her pants down and he would just pull down his pants and not his shirt. Ginsburg confirmed where JME was sitting when the defendant put his fingers in her vagina and she said either sitting on the toilet or sitting on the sink. Ginsburg confirmed where JME would be when the defendant put his fingers in her butt and she said she would be bent over holding the toilet. JME stated that her mom would be home when this happened and her mom would be cooking or watching TV, or eating, or washing the dishes or taking care of the puppies.

Further, your complainant believes the information furnished by Laura Becher and JME (DOB: 07/28/2007) to be truthful and reliable inasmuch as they are citizen informant(s) and witnessed the events described.
