The below-named complaining witness being first duly sworn states the following:

Count 1: OPERATING WHILE INTOXICATED - 6TH OFFENSE

The above-named defendant on or about Tuesday, April 3, 2018, in the City of Sun Prairie, Dane County, Wisconsin, did operate a motor vehicle while under the influence of an intoxicant, a controlled substance, a controlled substance analog or any combination of an intoxicant, a controlled substance and a controlled substance analog, under the influence of any other drug to a degree which renders him incapable of safely driving, or under the combined influence of an intoxicant and any other drug to a degree which renders him incapable of safely driving, contrary to sec. 346.63(1)(a), 939.50(3)(g) Wis. Stats., a Class G Felony, and upon conviction may be fined not more than Twenty Five Thousand Dollars (\$25,000), or imprisoned not more than ten (10) years, or both.

And furthermore, invoking the provisions of Wisconsin Statute Section 346.65(2)(am)5, the defendant shall be fined not less than \$600 and imprisoned for not less than 6 months if the number of convictions under ss. 940.09 (1) and 940.25 in the person's lifetime, plus the total number of suspensions, revocations and other convictions counted under s. 343.307 (1) since January 1, 1989, equals 5 or 6, except that suspensions, revocations or convictions arising out of the same incident or occurrence shall be counted as one.

And furthermore, invoking the provisions of sec. 343.30(1q)(b)4 and (1q)(c) Wis. Stats., upon conviction, the court shall revoke the defendant's operating privilege for not less than two (2) years nor more than three (3) years, and shall order the defendant to submit to an alcohol and drug abuse assessment and to comply with treatment as a condition of reinstatement.

FACTS:

Your complainant is a Court Officer with the City of Sun Prairie Police Department and for this complaint relies upon the written reports of City of Sun Prairie Police Officer Benjamin Pluim.

Off. Pluim reports on April 3, 2018 at approximately 1:20 AM, he observed a white Chevrolet Malibu operating westbound on W. Main St. approaching N. Walker Way, City of Sun Prairie, Dane County, Wisconsin. Off. Pluim ran a routine check of the vehicle registration and learned the vehicle's registration was expired and the registered owner's driver's license was suspended. Off. Pluim continued to follow the suspect vehicle. Off. Pluim reports when they got to the intersection of W. Main St. and O'Keeffe Ave. they stopped at the red traffic light. Off. Pluim reports when the light turned green, the suspect vehicle made a U-turn and began traveling eastbound on W. Main St. Off. Pluim activated his emergency lights and siren and also made a U-turn to follow the suspect vehicle. Off. Pluim reports the suspect vehicle continued traveling eastbound at an approximate speed of 15 to 20 MPH. The suspect vehicle then made a turn into the Hamilton Place Apartments where it pulled into a parking stall. Off. Pluim subsequently made contact with the driver, identified by Wisconsin driver's license as Bradley R. Wolf, the defendant herein.

Off. Pluim reports during his contact with Wolf, he observed Wolf had slurred speech and he detected the odor of alcohol coming from Wolf's person. Off. Pluim asked Wolf what he had consumed for alcohol that evening and wolf indicated he drank whiskey, clarifying he had consumed two whiskey and cokes in short glasses. Wolf stated he had consumed the beverages at a bar, approximately 30 minutes prior to the traffic stop.

Off. Pluim reports he administered field sobriety tests to Wolf who failed to adequately complete the tests. Off. Pluim reports he arrested Wolf for operating a motor vehicle while under the influence of intoxicants. Off. Pluim reports Wolf was transported to St. Mary's Emergency Department in Sun Prairie where Wolf submitted to a chemical test of his blood.

Your complainant has reviewed a teletype communication from the Division of Motor Vehicles, Wisconsin Department of Transportation, which reflects the driving record of the defendant as contained in the Division's records, maintained in the normal and ordinary course of business by said Division. Your complainant has referred to such teletypes in the past and found them to be reliable. The Division of Motor Vehicles records revealed that the defendant was convicted on November 4, 1996, in Dane County, of an offense counted under Wis. Stat. 343.307, for an incident that occurred on September 25, 1996. The Division of Motor Vehicles records revealed that the defendant was convicted on May 6, 2003, in Dane County, of an offense counted under Wis. Stat. 343.307, for an incident that occurred on November 29, 2002. The Division of Motor Vehicles records revealed that the defendant was convicted on February 3, 2004, in Dane County, of an offense counted under Wis. Stat. 343.307, for an incident that occurred on October 7, 2003. The Division of Motor Vehicles records revealed that the defendant was convicted on September 22, 2009, in Waushara County, of an offense counted under Wis. Stat. 343.307, for an incident that occurred on May 2, 2009. The Division of Motor Vehicles records revealed that the defendant was convicted on December 1, 2011, in Dane County, of an offense counted under Wis. Stat. 343.307, for an incident that occurred on September 8, 2010.

The teletype communications from the Division of Motor Vehicles, Wisconsin Department of Transportation, which reflects the driving record of the defendant is attached to this complaint and hereby incorporated by reference.
