The below-named complaining witness being first duly sworn states the following:

Count 1: STRANGULATION AND SUFFOCATION, DOMESTIC ABUSE ASSESSMENTS

The above-named defendant on or about Sunday, April 8, 2018, in the City of Fitchburg, Dane County, Wisconsin, did intentionally impede the circulation of blood or normal breathing by applying pressure on the throat or neck of another person, contrary to sec. 940.235(1), 939.50(3)(h), 973.055(1) Wis. Stats., a Class H Felony, and upon conviction may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than six (6) years, or both.

And further, invoking the provisions of sec. 973.055(1) Wis. Stats., because this charge is an act of domestic abuse, and further, invoking sec. 973.055(1), Wis. Stats., the court shall impose the domestic abuse assessment of \$100 for this offense because this charge is an enumerated crime under sec. 973.055(1)(a)1, Wis. Stats., and the conduct constituting the violation involved an act by the defendant against his or her spouse, against an adult with whom the defendant resides or formerly resided, or against an adult with whom the defendant has created a child.

Count 2: INTIMIDATION OF VICTIM, DOMESTIC ABUSE ASSESSMENTS

The above-named defendant on or about Sunday, April 8, 2018, in the City of Fitchburg, Dane County, Wisconsin, knowingly and maliciously did attempt to prevent or dissuade ZNJ, who has been the victim of a crime, from causing a complaint, indictment, or information to be sought or prosecuted or from assisting in the prosecution thereof, contrary to sec. 940.44(2), 939.51(3)(a), 973.055(1) Wis. Stats., a Class A Misdemeanor, and upon conviction may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than nine (9) months, or both.

And further, invoking the provisions of sec. 973.055(1) Wis. Stats., because this charge is an act of domestic abuse, and further, invoking sec. 973.055(1), Wis. Stats., the court shall

impose the domestic abuse assessment of \$100 for this offense because this charge is an enumerated crime under sec. 973.055(1)(a)1, Wis. Stats., and the conduct constituting the violation involved an act by the defendant against his or her spouse, against an adult with whom the defendant resides or formerly resided, or against an adult with whom the defendant has created a child.

Count 3: MISDEMEANOR BATTERY, DOMESTIC ABUSE ASSESSMENTS

The above-named defendant on or about Sunday, April 8, 2018, in the City of Fitchburg, Dane County, Wisconsin, did cause bodily harm to ZNJ, by an act done with intent to cause bodily harm to that person, without that person's consent, contrary to sec. 940.19(1), 939.51(3)(a), 973.055(1) Wis. Stats., a Class A Misdemeanor, and upon conviction may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than nine (9) months, or both.

And further, invoking the provisions of sec. 973.055(1) Wis. Stats., because this charge is an act of domestic abuse, and further, invoking sec. 973.055(1), Wis. Stats., the court shall impose the domestic abuse assessment of \$100 for this offense because this charge is an enumerated crime under sec. 973.055(1)(a)1, Wis. Stats., and the conduct constituting the violation involved an act by the defendant against his or her spouse, against an adult with whom the defendant resides or formerly resided, or against an adult with whom the defendant has created a child.

Count 4: DISORDERLY CONDUCT, DOMESTIC ABUSE ASSESSMENTS

The above-named defendant on or about Sunday, April 8, 2018, in the City of Fitchburg, Dane County, Wisconsin, while in a private place, did engage in violent, abusive, indecent, profane, boisterous, unreasonably loud and/or otherwise disorderly conduct, under circumstances in which such conduct tended to cause a disturbance, contrary to sec. 947.01(1), 939.51(3)(b), 973.055(1) Wis. Stats., a Class B Misdemeanor, and upon conviction may be fined not more than One Thousand Dollars (\$1,000), or imprisoned not more than ninety (90) days, or both.

And further, invoking the provisions of sec. 973.055(1) Wis. Stats., because this charge is an act of domestic abuse, and further, invoking sec. 973.055(1), Wis. Stats., the court shall impose the domestic abuse assessment of \$100 for this offense because this charge is an enumerated crime under sec. 973.055(1)(a)1, Wis. Stats., and the conduct constituting the violation involved an act by the defendant against his or her spouse, against an adult with whom the defendant resides or formerly resided, or against an adult with whom the defendant has created a child.

FACTS:

Your complainant is a Court Officer with the City of Fitchburg Police Department and for this complaint is relying on the official written police report submitted by City of Fitchburg Police Officer Nicholas Bartelt.

Officer Bartelt reports on April 8, 2018, at 8:09 P.M., he was dispatched to a residence located on Leopold Way, in the City of Fitchburg, Dane County, Wisconsin, for a check person. The caller, who was later identified with a name that forms the initials SME, received a Facebook

message from a friend saying to call the police. SME was unsure why, but thought it was because of boyfriend issues. SME had reported that her friend's boyfriend was crazy obsessive, and was told if she ever receives a message saying call the police, it means the boyfriend was over and she was afraid of him.

Officer Bartelt reports while en route, Officer Bartelt called SME. Officer Bartelt introduced himself as Officer Bartelt with the Fitchburg Police Department and asked what was going on. SME said she received a Facebook message from her friend, who Officer Bartelt later identified with a name that forms the initials ZNJ, to call the police.

SME said she didn't know what was going on, but called the police to report what her friend messaged her. Officer Bartelt asked SME if she could give Officer Bartelt a description of the boyfriend, and she said he is a black male, eighteen years of age, and goes by the nickname Savage. Officer Bartelt reports that Officer Khilji later identified Savage through his state issued birth certificate as Juwan J. Wilson, date of birth March 20, 1997, the defendant herein. Officer Bartelt asked SME if she knew if Juwan owned any weapons. SME said Juwan owned a gun, but not sure what kind.

Officer Bartelt reports at 8:19 P.M., he arrived at the Leopold Way address, in the City of Fitchburg, Dane County, Wisconsin. Officer Bartelt went inside of the apartment complex. Officer Bartelt stood outside an apartment and could hear a male and female arguing. After listening from the hallway for a couple minutes, Officer Bartelt knocked on the door to the apartment. The arguing coming from inside the apartment had stopped. There was no answer so Officer Bartelt knocked on the door again. After a few minutes, the female identified as ZNJ answered the door and Officer Bartelt introduced himself. When ZNJ answered the door, Officer Bartelt noticed blood on the left cheek of her face.

Officer Bartelt reports while standing at the doorway trying to figure out what was going on, Officer Bartelt could see ZNJ shaking uncontrollably. Officer Bartelt asked ZNJ if everything was okay, and she began to have tears run down both sides of her face.

Officer Bartelt asked ZNJ if her boyfriend was inside, and she said he was. ZNJ said he was getting ready to leave. Officer Bartelt asked if the officers could come inside and talk to him. ZNJ didn't answer, but looked at the officers and nodded her head yes.

Officer Bartelt reports he and Officer Khilji entered the apartment and asked if Savage (Juwan) was there. Savage said he was. Officer Khilji met Juwan in the living room. Officer Bartelt overheard Juwan say he was packing some things to leave for the night.

Officer Bartelt reports while in the hallway, Officer Bartelt asked ZNJ what was going on. ZNJ said she and the man she identified, and who Officer Khilji identified in full as Juwan J. Wilson, date of birth March 20, 1997, the defendant herein, got into an argument. While standing there, ZNJ was still shaking uncontrollably and crying.

Officer Bartelt told ZNJ that he could see that she was afraid by the way she was acting. ZNJ asked if they could go outside to talk about what happened. ZNJ said she did not want Juwan to hear her talking to the police.

After going outside, ZNJ explained that Juwan got mad at her when he was going through her cell phone and saw messages between her and another individual. ZNJ said Juwan started yelling at her and calling her names. ZNJ asked Juwan to stop and told him he needed to leave. Juwan did not leave. ZNJ asked Juwan for her phone back. She told Juwan she was going to call the police and he would not give her the phone back.

Officer Bartelt asked ZNJ if she was disturbed when Juwan would not give her the phone back. ZNJ said she was.

Officer Bartelt asked ZNJ what happened next, and she did not want to answer any more questions. ZNJ said she was worried that Juwan would find out she was talking to police, and was afraid Juwan or his friends were going to hurt her. Officer Bartelt told ZNJ that the officers were going to do their best to prevent that from happening.

Officer Bartelt told ZNJ that the officers were worried about her safety. Officer Bartelt asked ZNJ if she could tell the officers what happened. ZNJ said that they got into an argument and she went into her roommate's room and shut the door. ZNJ used her body to block the door because it did not lock. ZNJ used her roommate's cell phone to message SME on Facebook since Juwan had her phone.

ZNJ said Juwan was beating and kicking on the door. Juwan eventually broke the door hinges and forced his way into the bedroom. ZNJ stated that she was scared when this happened.

ZNJ explained that she told Juwan he needed to leave. Juwan continued to yell at ZNJ and call her names. After speaking with ZNJ, it seemed that she was still withholding information. Officer Bartelt told ZNJ that he believed there was more information than what she was telling the officers. ZNJ said there was, but she was afraid to say since Juwan was still there. ZNJ did not want to share anymore information in case Juwan did not leave for the night.

Officer Bartelt asked ZNJ if Juwan had physically assaulted her. At this point, ZNJ mentioned that Juwan bit her on the inside bicep of her left arm. Officer Bartelt asked ZNJ to rate the pain on a scale of zero to ten, with ten being the most pain she's ever felt. ZNJ said it was an eight. Officer Bartelt asked ZNJ how Juwan stopped biting her, and she said she had pushed him off of her.

Officer Bartelt asked ZNJ how long she and Juwan had been dating, and ZNJ said, "On and off for about a year." ZNJ said the lease started on April 1, 2018. She said Juwan had lived in Chicago and moved in with her this past weekend. Officer Khilji informed Officer Bartelt that while interviewing Juwan in the bedroom, he observed Juwan had bags of clothes inside. Officer Bartelt reports that Officer Khilji believed Juwan had just moved into the apartment.

Officer Bartelt asked ZNJ if she consented to Juwan biting her, and she did not give consent.

As Officer Bartelt spoke with ZNJ, Officer Bartelt observed she had a scratch mark above her right eye. The scratch started to turn bright red and appeared to be approximately two inches long. It also started to swell up. Officer Bartelt believed this scratch mark was recent.

Officer Bartelt reports based on the information ZNJ gave the officers, and from their observations, it was decided that Juwan Wilson, the defendant, would be placed under arrest. Officer Bartelt reports that Officer Khilji took Juwan into custody and escorted him to his squad.

Officer Bartelt reports while Officer Khilji was escorting Juwan to his squad, ZNJ saw him in handcuffs. Officer Bartelt asked if ZNJ would be willing to talk more about what happened now that Juwan was in handcuffs and out of the apartment. ZNJ said she was willing to talk.

Officer Bartelt reports he and ZNJ went back inside to talk. ZNJ was not wearing the long-sleeved sweater anymore, and Officer Bartelt asked her if he could see her bite mark. ZNJ showed Officer Bartelt the bite mark, and Officer Bartelt could see the outline.

Officer Bartelt reports the scratch above her right eye was now bumped out even more and you could see a white scratch mark on top of the redness.

Officer Bartelt reports ZNJ explained that she was sleeping in her bedroom when Juwan woke her up by hitting her in the head. ZNJ said Juwan was in her room looking at her phone while she was sleeping. That's when Juwan found the text messages between ZNJ and another individual.

Officer Bartelt asked ZNJ if she remembered how many times Juwan had hit her. ZNJ said she did not know. Officer Bartelt asked ZNJ if it was more than five, and she said yes. Officer Bartelt asked ZNJ if it was more than ten, and she said yes. ZNJ said she told Juwan to stop and then she left the room to go use the bathroom.

ZNJ further explained that while she was in the bathroom, Juwan came into the bathroom and put his hands around her neck. ZNJ said Juwan was squeezing her neck so hard she could not tell him to stop. ZNJ said she could not breathe with Juwan's hands around her neck. ZNJ said she grabbed Juwan's hands and tried pulling them off her neck. ZNJ was also kicking Juwan, trying to get him to stop. ZNJ said she felt like at one point she was about to lose consciousness. Juwan also shut the door to the bathroom.

ZNJ said her roommate came into the bathroom and was trying to stop Juwan. ZNJ said once Juwan let go, she went out to the living room and sat on the couch.

ZNJ further explained Juwan followed her into the living room, yelling at her and calling her names again. Again ZNJ asked him to leave, and the fight got physical again. ZNJ said this time Juwan got on top of her on the couch and began to strangle her again. ZNJ said she could not to breathe.

ZNJ said she tried pulling Juwan's hands off her neck, and was kicking him to get him off. ZNJ said once Juwan was done strangling her she got up. Juwan then grabbed her hair on the back of her head and was punching her in the head multiple times. Juwan was also hitting ZNJ in the face. ZNJ said that her jaw was sore and hurt to open.

Officer Bartelt reports ZNJ said they could call EMS for her. EMS arrived on scene, the paramedics came in and assessed ZNJ injuries. They recommended that ZNJ go to the hospital and get checked out because they could not see what internal injuries she might have.

Officer Bartelt reports he asked ZNJ questions about the strangulation from his law enforcement resource card that Officer Bartelt was issued from the Fitchburg Police Department.

ZNJ said her voice was hoarse and raspy. ZNJ said she had ringing in her ears when Juwan was hitting her in the head repeatedly. ZNJ said she could not breathe when Juwan had his hands around her neck and she almost lost consciousness. ZNJ also said her head was pounding and her jaw hurt to open.

Officer Bartelt asked ZNJ if he could take a closer look at her neck. Officer Bartelt could see what appeared to be impressions of fingers on both sides of her neck. While looking closer at ZNJ's neck and face more marks were starting to appear. Officer Bartelt asked to see ZNJ's tongue. Officer Bartelt observed multiple red spots. Officer Bartelt reports based on his training, Officer Bartelt believed this to be petechia.

Officer Bartelt asked ZNJ again how Juwan strangled her in the bathroom and living room. ZNJ said Juwan was using both hands and applying physical force. Officer Bartelt asked ZNJ if she could describe the force. ZNJ advised that in the bathroom it was mostly just upper body strength. Officer Bartelt asked ZNJ about the strangulation in the living room, and she said it felt like Juwan was using a lot more body weight in strangling her.

Officer Bartelt asked what Juwan saying was while strangling her, and ZNJ could not remember. Officer Bartelt asked ZNJ what she did to try and stop Juwan. ZNJ said she tried pulling his hands off and kicking him.

Officer Bartelt asked ZNJ how the strangulation stopped. ZNJ said it appeared Juwan saw she was about to lose consciousness and stopped.

Officer Bartelt reports while sitting on the stairway, Officer Bartelt could start to see more red marks and bumps forming on the left side of ZNJ's face and ear. Between ZNJ's left ear and eye, there was a bump that appeared to be the diameter size of a half dollar. ZNJ also had a scratch behind her left earlobe and redness to the interior of her left ear.

Officer Bartelt again asked ZNJ if she gave Juwan Wilson, the defendant, permission to hit and strangle her, and ZNJ said "No."

Officer Bartelt asked ZNJ if she would be willing to sign a medical release form, and she signed the form. Officer Bartelt also provided ZNJ copies of the victim information form and the 72-hour no contact form. ZNJ elected to enforce the 72-hour no contact provision.

Bartelt, which report your complainant believes to be truthful and reliable inasmuch as they were prepared during the course of the officer's official duties.

Further, your complainant believes the information furnished by SME and ZNJ to be truthful and reliable inasmuch as they are citizen informants and witnessed the events described.
